

Course: Advanced Emergency Medical Technician

- The course is being conducted in a hybrid format. In person classes will occur on Wednesdays from 0800-1600 hours. Asynchronous course work will need to be completed outside of class, throughout the week.
- This certification program is a two-part certification process. The student will complete the Advanced EMT (AEMT) Training Program and upon completion, will take the National Registry of Emergency Medical Technicians (NREMT) cognitive examination and the Pennsylvania Department of Health Bureau of EMS psychomotor examination conducted by MATI.
- Students will complete a total of 292 hours of education including, but not limited to, 152 hours of didactic and psychomotor training, 60 hours of field precepting, 60 emergency department clinical precepting, and a 20-hour field internship. **As a result of the need to be patient facing, all students must be fully vaccinated for COVID-19 or have an appropriately documented religious or medical exemption.**
- Students must be at least 18 years of age to enroll in the AEMT Training Program and maintain a valid Emergency Medical Technician-Basic certification throughout the duration of the Program.
- **Applications for the program will open April 1, 2025, and are due no later than June 1, 2025.** Students will then be invited for interviews between June 2-13, 2025. A letter of conditional acceptance will be issued no later than June 16, 2025, to those candidates admitted into the program. All admitted students will be required to complete all course prerequisites (background checks, physicals, drug screenings, etc.) no later than August 4, 2025.
- Students must have the necessary mental acuity, practical skills, motivation, and mental attitude necessary to complete the program. Students must adhere to the physical performance guidelines as outlined in the *Pennsylvania Department of Health Functional Position Description for ALS Provider*. In addition, the candidates must possess the perseverance to provide quality patient care, even under difficult circumstances.
- **Tuition: \$1,500.00– minimum deposit of \$750.00 due on the first day of class.** The remaining balance must be satisfied by November 12, 2025. A \$250.00 payment will be due on the first of every month, throughout the program. Checks should be made payable to **Mutual Aid Ambulance Service, Inc.**, unless other arrangements have been made. **No cash will be accepted.** Tuition payments will not be accepted prior to the first day of class. Tuition includes the required testing fees, technology access, uniforms, and liability insurance.

- The Program's goal is "To prepare competent entry-level Advanced Emergency Medical Technicians in the cognitive (knowledge), psychomotor (skills), and affective (behavior) learning domains with or without exit points at the Emergency Medical Technician, and/or Emergency Medical Responder levels."
